The applicant further agrees that the City shall have the right to charge and collect such rates and enforce such penalties as provided by Resolution and to temporarily discontinue water service at any time without notice, and further agrees that in case the supply of water shall be interrupted or shall fail by reason of accident or any other cause whatsoever, the City shall not be liable for damages for such interruption or failure nor shall such failures or interruptions for any reasonable period of time be held to constitute a breach of contract on the part of the City or in any way relieve the applicant from performing the obligations of this contract.

Unless otherwise specified, applicant agrees to pay for water service from date of request of service. Applicant agrees to be responsible for all bills for water service to this property resulting from the installation of this service connection, and to notify the City in writing of any change of ownership of the property to be served.

In consideration of the applicant's paying the charges and the rates and abiding by the conditions herein set forth, and those established resolutions of the City, the City agrees to furnish water to the described property according to the terms and conditions of this application. The applicant agrees that the City shall have the right to enter upon the property of applicant when necessary to maintain or repair any facilities which are part of the water system of the City.
