## INFORMATION REQUIRED WHEN APPLYING FOR APPROVAL OF A PLANNED RESIDENTIAL DEVELOPMENT (PRD)

### PRE-APPLICATION REVIEW

Prior to filing the formal application described below, the applicant must submit plans of the proposal to the Planning Director for review and comment. Such potential problems as drainage, topography, circulation, site design, and neighborhood impact will be identified and addressed during the course of this pre-application review.

### APPLICATION

An application must be filed with the Planning Department to initiate the request for approval of a planned residential development. An application will not be accepted until complete, as determined by the Planning Department. A complete application must include:

1. Application Form (Attached).
2. Environmental Checklist (EC). The EC will be reviewed by the City's designated "responsible official," who will determine if there appears to be a probable significant environmental impact; if so, an Environmental Impact Statement (EIS) may be required. The EC may not be required in all instances; the applicant is advised to consult with the Planning Department as to whether an EC is required for the proposal.
3. Adjacent Property Owners List. A notarized letter and a set of self-adhesive address labels from a title company listing names, addresses, and parcel numbers of owners of all property located within 300 feet of the property involved are required.
4. Legal Description. The applicant must submit a complete legal description that adequately describes the property for which the planned residential development is requested. This legal description will be checked and verified by the Engineering Department. Inadequate legal descriptions will be returned for corrections.
5. Preliminary Plan Drawing. A reproducible preliminary plan drawn to a scale of 1" = 40' is required. This drawing must include:
  - a. Proposed name of the development;
  - b. Location by section, township, range, and/or by other legal description;
  - c. Names, addresses and phone numbers of the developer(s), property owner(s), and registered land surveyor preparing the plan;
  - d. Scale of plan, date, and north point;
  - e. Existing topography of the land indicated by contours at 5-foot intervals or less, except where a slope exceeds 50%, then the interval may be 10 feet. All elevations shall be based on City of Pullman datum;
  - f. Land use zoning classification and the floodplain zone classification;
  - g. The land or lot divisions of adjoining properties within 100 feet of the boundary of the property;
  - h. The general layout of all proposed structures, common areas and facilities, and circulation elements, including walkways, bike paths, and parking in sufficient detail to show relationships between these elements;
  - i. Location, widths, and names of existing or prior platted and proposed streets, railroad or utility right-of-way or easements, parks or other public spaces, pedestrian walkways and existing permanent structures to be retained within and adjacent to the property;
  - j. Existing and proposed water and sewer lines, utilities on, under, or over the land showing approximate size, grades, and locations;
  - k. Location of all ditches, culverts, catch basins, and other parts of the design for the control of surface water drainage;
  - l. Typical roadway section right-of-way to right-of-way and approximate grade for all proposed streets.

6. Covenants. The applicant must submit proposed covenants that prescribe architectural design elements for all structures to be built within the planned residential development, addressing such matters as general architectural style, building size, roof material and design, exterior surfaces, and accessory structures.
7. Vicinity Map. A map of the surrounding area showing existing uses within 300 feet of all project boundaries is required.
8. Explanatory Material. A written description of the characteristics of the proposal and the planned construction schedule is required.
9. Landscape Plan. The applicant must submit a landscape plan, drawn to scale, showing the general layout of existing and proposed vegetation including vegetation to be removed, fences, walls, and other landscaping improvements. The landscape plan may be combined with the preliminary plan drawing.
10. Proof of Ownership/Permission from Owner. The applicant must submit proof of ownership of the property in question. All owners must join in or be represented in the application. If the applicant is not the owner of the subject property, an affidavit must be submitted by the owner granting the applicant permission to act as his/her agent.
11. (OPTIONAL) Plat. An applicant who intends to subdivide land for transfer as part of a planned residential development project shall apply for approval of the short or long subdivision in accordance with the appropriate city code provisions concurrently with the planned residential development proposal.

All plans and maps required as part of this application shall be prepared in a reproducible format on a sheet with minimum dimensions of 8½ inches by 11 inches and maximum dimensions of 24 inches by 36 inches.
