



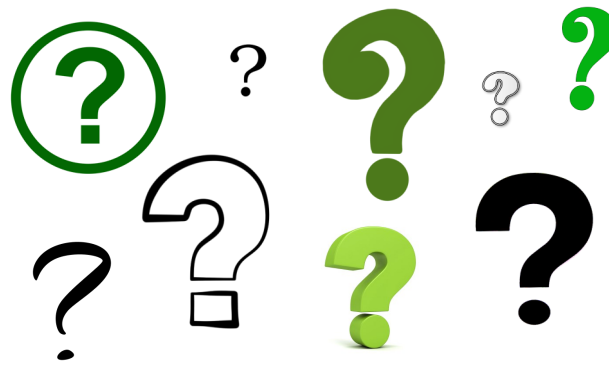
## City of Pullman Regulations

The City of Pullman reinforces the restriction of licenses to retailers, producers, and processors located within 1,000 feet of sensitive locations.

Licensed production must take place indoors.

No off-site sale or delivery is permitted.

Drive-through sales are prohibited.

## Legalization of Marijuana





### **Fast Facts:**

## **Washington Initiative 502 Recreational Marijuana**

- Personal possession is lawful only for those 21 years of age, or older.
- Allowable possession quantities vary:
  - Useable (dry) Marijuana: 1 oz.*
  - Marijuana-Infused Product (solid): 16 oz..*
  - Marijuana-Infused Product (liquid): 72 oz.*
- It is a civil infraction to display or use marijuana in public view. Use in vehicles or on public roadways is prohibited.
- Washington medical marijuana laws have not been changed by I-502.
- Federal marijuana laws have not changed. It is the user's responsibility to know the laws surrounding marijuana.
- It is illegal to transport marijuana to a state where possession is illegal.
- Employers and landlords may impose their own rules upon employees and building tenants.



## **I-502 & Impaired Driving**

DUI marijuana enforcement is not new. However, the rules have changed.

Adults (21+) will receive a DUI for THC levels of 5 ng/mL or higher.

There is zero tolerance for minors. Any minor with THC levels greater than 0 will be cited for DUI.

### Marijuana impairment tests include:

- Field sobriety on-scene testing
- Blood testing



## **Licensing: Producers, Processors & Retailers**

Licensing is regulated by the Washington Liquor Control Board (LCB).

Licenses are restricted to areas greater than 1,000 ft. from schools, playgrounds, child care centers, recreation centers or facilities, public parks, transit centers, libraries, or gaming arcades that allow minor admission.

Retailers may not be licensed as processors or producers of marijuana. Retailers are only permitted to sell marijuana, marijuana-infused products, and marijuana paraphernalia.

The Liquor Control Board places geographical restrictions on licenses:  
*Pullman: 3 retail licenses*  
*Whitman County: 1 additional retail license*
