ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Pullman from January 1, 2009 through December 31, 2010.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Billings/receivables
- Contracts/agreements
- Restricted funds
- Open public meetings/records laws
- Building permit process
- Disbursements/expenditures
- Conflict of interest/ethics laws
- Police – financial operations, custody of evidence and unclaimed property

RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE CITY

The City of Pullman was incorporated on April 11, 1888, and currently serves approximately 29,720 Whitman County residents. It provides an array of services including police, fire, ambulance, water supply treatment and distribution, sewage treatment and collection, street maintenance, transit, planning and zoning and public facilities such as a library, parks and recreation and cemeteries.

An elected, seven-member Council with a separately elected Mayor governs the City. The Council appoints management to oversee the City's daily operations as well as its 300 employees. For fiscal year 2010, the City operated on an annual budget of approximately \$47 million.
